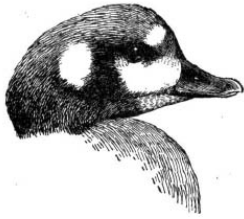

## TOUR PARTICIPANT AGREEMENT

We hope to provide you with a pleasant traveling experience. Travel will be by boat and by motor coach. The boat is the MV Glacier Spirit, a well-appointed and comfortable 65-foot motor yacht, with enclosed cabin containing benches, tables, life vests, a galley, and bathroom. The boat captain is an experienced professional. Lunches will be served enroute, and are included. Alcoholic beverages may be purchased from the galley. We thank you for not smoking on the vessel.

Motor coaches will be comfortable, climate-controlled vans, or units of regional transit systems. We thank you for not smoking or consuming alcohol on the motor coaches.

A tour director will be along to escort you to meals, special attractions, hotels, and provide you with information. We want each person to feel comfortable.

Gratuities for driver, escort, hotel porters, catered or arranged meals, and step-on guides have been included. You should tip for wait service for meals you purchase or for room service at hotels.

Every attempt is made to select rooms that must meet high standards for cleanliness, comfort, and convenient location. We request that you do not smoke, as they are non-smoking rooms.

Locations for meals are carefully planned and screened. We endeavor to choose facilities that offer several choices at reasonable prices. Special meals will sometimes be provided, as well.

On arrival at hotels, the participant will register at the registration desk and obtain their room key. Each tour member is allowed one large suitcase, plus a small day pack or tote bag. An identification tag must be on every bag, carry-on, camera case, etc. included. The resort has a shuttle that will take you to your room. Olympic Peninsula Audubon Society does not assume liability for loss of or damage to luggage or other personal property.

All personal charges at nightly accommodations such as telephone calls, room service, etc. must be paid for first thing in the morning before departing the hotel. Please be aware of any fees or hotel policies on telephone or other charges, as they may vary at each hotel. The tour director cannot settle the tour account until all personal charges have been paid.

In the event a tour participant requests a room with another participant on the tour, the participants hereby expressly waive, both individually and on behalf of any heirs, successors, assigns, or persons otherwise entitled, the right to bring any claim for damages of injury of any kind against Olympic Peninsula Audubon Society which may arise from or are related to such rooming arrangement, including any claim for liability for property damage, theft, vandalism, or personal injury of any type whatsoever.

We will be traveling on a schedule. If there are any revisions to the itinerary, your tour director will advise you of those changes and you should note them on your itinerary. **PLEASE BE ON TIME.** One late person inconveniences the entire group and can have a serious impact on the rest of the daily activities.

The trip is created for active travelers. You must be able to walk to and from the accommodations and attractions included. If you have questions about the level of physical exertion required, please call and we will give you an assessment of what to expect.

Anyone making a tour reservation should be in good physical and mental health and not require more than reasonable assistance from motor yacht crew or motor coach driver, tour director, or other members of the tour. All tour participants will be required to complete truthfully a medical information form. If a tour participant requires special physical assistance, that participant is responsible for being accompanied by a qualified helper who assumes total responsibility for the participant's well-being.

Olympic Peninsula Audubon Society reserves the right to exclude from the tour any participant whose physical condition or conduct impairs customary operation of the tour, even after the tour is in progress. Should any physical or mental handicap become apparent while on the tour, and cause hardship to the captain, driver, or tour director and/or other tour members, or if a participant's conduct is deemed incompatible with or disruptive to the interest of the tour group, the captain, driver, or tour director retains the right to expel that person or persons from the tour. Should a tour participant leave the tour early, for any reason, whether voluntarily or through expulsion, any expenses incurred for the tour participant to return home are the responsibility of the participant and all tour fees and costs are forfeited.

Olympic Peninsula Audubon Society reserves the right to substitute nightly accommodations and other service providers of a similar category and/or quality, or make changes in the schedule without prior notice should circumstances demand. In the event of a change in the itinerary caused by conditions or factors beyond the control of Olympic Peninsula Audubon Society, no refund can be made, nor will credit be allowed, provided that in the event of such change in itinerary, Olympic Peninsula Audubon Society may provide accommodations and services of comparable quality and standards.
